I, the undersigned, confirm that:

I have been informed by the Ethiopian Human Rights Commission that they intend to conduct a national inquiry into persons who have been arbitrarily and unlawfully deprived of liberty and that they intend to hold a public hearing on the deprivation of liberty.

I have been advised that the Ethiopian Human Rights Commission (EHRC) is an independent National Human Rights Institution (NHRI) established by Proclamation No.210/2000 (as amended by Proclamation No.1224/2020). The Commission is mandated to promote and protect human rights, and it is in this context that they intend to conduct the national inquiry as set out above.

I, or on behalf of the entity, have been invited to give relevant information about the human rights violations perpetrated against the victim/s and their family, including the harm suffered and the consequences.

I, or on behalf of the entity, confirm that I freely and voluntarily, agree to participate in submitting relevant information to the national inquiries conducted in Amhara and Oromia regions and have agreed to provide any documents relevant to it on the human rights violations perpetrated against victim/s, and which resulted in the deprivation of liberty.

Having been informed of my rights, I, or on behalf of the entity, confirm and give my informed consent to the EHRC to share the information, and use my information in their report. My submissions may also be shared by the EHRC with state officials of the government of Ethiopia for the purposes of obtaining further information as well as a response from the government. I am aware that my submission identifies me by name, provides my contact details, and provides general information on the nature and scope of the violations.

My consent to the EHRC sharing my information with the Government is conditional upon them treating the information with utmost confidentiality, ensuring that no information is made public in any way whatsoever i.e. (a) my or the entity's name and the names of my family members or (b) my current residential address or that of my family members as well as any other identifying features, including specifics about my particular experience that might identify me or my family members or other victims and witnesses or the entity.

I confirm having been informed that if I have any security concerns, that I should contact the Inquiry Commissioners or the regional offices who will take steps to address them.
